## CHAPTER 7

An act to repeal and add Section 4 of Chapter 375 of the Statutes of 1986, relating to the Coast Life Support District, and declaring the urgency thereof, to take effect immediately.

[Approved by Governor February 6, 1988. Filed with Secretary of State February 8, 1988.]

## LEGISLATIVE COUNSEL'S DIGEST

AB 2672, Hauser. Coast Life Support District.

Existing law establishes the Coast Life Support District to provide emergency medical services, including emergency ambulance and life support services and certain other health services to a specified area within Sonoma and Mendocino Counties.

This bill would revise the territory of the district, as specified, and by so doing would impose certain duties on the counties with respect

to the operation of the district.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this

act for a specified reason.

This bill would declare that it is to take effect immediately as an urgency statute.

The people of the State of California do enact as follows:

SECTION 1. Section 4 of Chapter 375 of the Statutes of 1986 is repealed.

SEC. 2. Section 4 is added to Chapter 375 of the Statutes of 1986,

to read:

Sec. 4. Beginning at the northerly boundary of the Irish Beach Water District, being a portion of Sections 5 and 6, T 13N, R 16W, and portions of Sections 31 and 32, T 14N, R 16W, MDM, at the mean high water mark of the Pacific Ocean; thence easterly along said boundary to a ½ inch iron pipe tagged LS 3089 located at the northeasterly corner of lot 31 Mendocino Coast unit #3, recorded in map case 2, drawer 8, page 29, Mendocino County Records; thence south 89 15'20" east, 129.39 feet; thence north 44 58'38" east 316.76 feet; thence along the arch of a tangent curve to the right, having a radius of 155 feet, through a central angle of 115 26'49", a length of 312.31 feet; thence south 19 34'33" east, 110.31 feet; thence south 16 36'25" east, 72.52 feet to a point on the south line of the northeast quarter of the southwest quarter of said Section 31, T 14N, R 16W; thence east 918.46

feet along said line to the northeast corner of the southeast quarter of the southwest quarter of said Section 31; thence north 2,640 feet to the northwest corner of the southwest quarter of the northeast quarter of Section 31: thence east 3,960 feet to the northeast corner of the southwest quarter or the northwest quarter of Section 32, T 14N, R 16W; thence south 2.640 feet to the northeast corner of the southwest quarter of the southwest quarter of the Section 32; thence east 2,640, feet to the northwest corner of the southeast quarter of the southeast quarter of Section 32; thence south 1,320 feet to a point on the township line at the southwest corner of the southeast quarter of the southeast quarter of Section 32; thence east along the common Township 13N and 14N line to the northeast corner of lot 1, Section 5, Township 13N, R 16W; thence northerly along the east line of Sections 32 and 29, to the northeast corner of Section 20, and thence easterly and along the north line of Sections 21, 22, 23 and 24 to the NE corner of said Section 24 said corner being on the range line common to Ranges 15 and 16 west; thence southerly and along said range line to the NW corner of Section 19, T 13 N, R 15 W; thence easterly and along the north line of Sections 19, 20, and 21 to the SW corner of Section 15; thence northerly and along the west line of Sections 15, 10, and 3 to the NW corner of said Section 3; thence easterly and along the north line of Sections 3 and 2 to the NE corner of said Section 2; thence southerly along the east line of said Section 2 to the NW corner of Section 12; thence easterly and along the north line of Section 12 to the north 1/4 corner thereof; thence southerly and along the 1/4 section line to the north 1/4 corner of Section 13; thence easterly and along the north line of Section 13 to the NE corner thereof; thence southerly and along the east line of said Section 13 to the SE corner thereof, said corner being on the range line common to Ranges 14 and 15 west; thence easterly and along the north line of Section 19, T 13 N, R 14 W, to the north 1/4 corner thereof; thence southerly through the center of Sections 19, 30, and 31 and along the 1/4 section line thereof to the south 1/4 corner of Section 31, said corner being on the township line common to Townships 12 and 13 North; thence easterly and along said township line to the NE corner of Section 4, T 12 N, R 14 W; thence southerly and along the east line of Sections 4 and 9 to the NW corner of Section 15; thence easterly and long the north line of Sections 15 and 14 to the E 1/16 corner of said Section 14; thence southerly along the east 1/16 line thereof to the NE 1/16 corner thereof; thence easterly along the 1/16 section line to the N 1/16 corner of said Section 14; thence southerly and along the east line of Sections 14, 23, 26, and 35, T 12 N, R 14 W; thence continuing southerly along the east line of Sections 2, 11, 14, and 23 to the common boundary between Mendocino and Sonoma Counties; thence easterly, northerly, and easterly along said boundary to the common corner of Sections 8, 9, 16, and 17, T 11 N, R 12 W; thence south along the east line of Sections 17, 20, 29, and 32, T 11 N, R 12 W, to the south line of Section 32, thence west along

the south line of Sections 32 and 31, T 11 N, R 12 W and Section 36 T 11 N, R 13 W to the range line between T 10 N, R 12 W and T 10 N, R 13 W; thence south along range line to the southeast corner of Lot 3 of Section 1, T 10 N, R 13 W; thence along the south boundary of said Lot 1 and Lot 8 westerly to the east line of Section 2 T 10 N, R 13 W; thence southerly along the east line of said Section 2 to the easterly 1/4 corner thereof; thence easterly along the east-west 1/4 section line of Section 2 to the northeast corner of the NW 1/4 of the SW 1/4 of said Section 2; thence southerly along the 1/16 line to the northeast corner of the SW ¼ of the SW ¼ of said Section 2; thence westerly along the 1/16 line to the east line of Section 3 T 10 N, R 13 W; thence southerly to the northeast corner of Section 10; thence westerly along the northerly line of Section 10 to the northwest corner of the NE ¼ of the NE ¼ of Section 10; thence southerly along the 1/16 line to the east-west 1/4 section line of said Section 10; thence westerly along said 1/4 section line to the northwesterly corner of the NE 1/4 of the SW 1/4 of said Section 10; thence southerly along the 1/16 line to the northeast corner of the SW 1/4 of the SW 1/4 of said Section 10; thence westerly along the 1/16 line to the east line of Section 9, T 10 N, R 13 W; thence southerly along the east line of Sections 9 and 16 to the NW corner of the SW 1/4 of the SW 1/4 of Section 15, T 10 N, R 13 W; thence easterly along the 1/16 line of said Section 15 to the northeast corner of the SW 1/4 of SE 1/4 thereof; thence along the north-south 1/4 section line of said Section 15, southerly to the north line of Section 22, T 10 N R 13 W; thence easterly along said north line of Section 22 to the NW corner of Section 23; thence southerly along the common line of Sections 22 and 23 to the southwest corner of the NW 1/4 of the NW 1/4 of said Section 23; thence easterly along the 1/16 line to the southwest corner of the NE 1/4 of NE 1/4 of said Section 23; thence northerly along the 1/16 line to the north line of said Section 23; thence easterly along the north line of Section 23 to the NE corner of said Section 23; thence northerly along the common line between Sections 13 and 14, T 10 N, R 13 W, to the west ¼ corner of said Section 13; thence easterly along 1/4 section line to the center of said Section 13; thence southerly along the north-south 1/4 section line to the NW corner of the SW 1/4 of the SE 1/4 of said Section 13; thence east along the 1/16 line to range line between R 13 W and R 12 W; thence southerly along said range line to the NW corner of Section 6 T 9 N, R 12 W; thence easterly along the northerly line of Sections 6, 5, 4, 3, 2, and 1 to the northeast corner of said Section 1; thence southerly along the east line of Sections 1, 12, and 13 to the southeast corner of said Section 13; thence westerly along the southerly line of Sections 13, 14, 15, 16, and 17 to the common corner to Sections 18, 17, 19, and 20 of T 9 N, R 12 W; thence northerly along the west line of said Section 17 to the northwest corner thereof; thence westerly along the common section line of Sections 18 and 7 to the range line between R 13 W and R 12 W; thence northerly along said range line to the SE corner of Section 12 T 9 N, R 13 W; thence

westerly along the southerly line of Sections 12, 11, 10, and 9 to the common corner of Sections 8, 9, 17, and 16; thence southerly along the east line of said Section 17 and Section 20 to the intersection with the center line of the south fork of the Gualala River: thence northwesterly along the south fork of the Gualala River to its intersection with the north line of Section 18 T 9 N, R 13 W; thence west along the north line of said Section 18 to the 1/4 section line running north and south through the center of said Section 18: thence south along the said 1/4 section line to the south line of the north 1/2 of the northwest 1/4 of said Section 18; thence west along the south line of the said north 1/2 of the northwest 1/4 of Section 18 to the range line between T 9 N, R 13 W and T 9 N, R 14 W; thence south along the said range line to its intersection with the northeasterly line of the German Rancho; thence southeasterly along the northeasterly line of the German Rancho to its intersection with the southerly line of the lands of A.H. Richardson; thence southwesterly along the southerly line of the lands of A.H. Richardson to a point of intersection with the mean high tide mark of the Pacific Ocean; thence northwesterly along the Pacific Ocean to the Point of Beginning.

SEC. 3. No reimbursement is required by this act pursuant to Section 6 of Article XIII B of the California Constitution because this act is in accordance with the request of a local agency or school district which desired legislative authority to carry out the program

specified in this act.

SEC. 4. This act is an urgency statute necessary for the immediate preservation of the public peace, health, or safety within the meaning of Article IV of the Constitution and shall go into immediate effect. The facts constituting the necessity are:

In order for Mendocino and Sonoma Counties to collect assessments as authorized for the Coast Life Support District this

year it is necessary that this act go into immediate effect.
