Finance Committee

Minutes of Meeting November 15, 2023, at 9 am - Bill Platt Training Center

This meeting was held by teleconference and in person.

- Call to Order: The meeting was called to order at 9:00 am by Treasurer Michael Tilles. Also present: Director Naomi Schwartz, Director Geoffrey Beaty, DA David Crowl, Captain Bronwyn Golly, Bookkeeper Robin Dills. Member of the public, Scott Foster
- 2. Agenda Approval: Director Beaty moved to adopt the agenda, seconded by Director Schwartz. All ayes.
- **3. Meeting Minutes Approval:** Director Beaty moved to approve the 18, October 2023, FC meeting minutes, seconded by Director Schwartz All ayes.
 - **4. Privilege of the floor:** Scott Foster, former CLSD District Administrator, share historical information regarding areas in CLSD that receive a parcel tax bill....specifically down in Timber Cove. Some of land owners in that neighborhood were exempted from that parcel tax. Mr- Foster gave us information about how that decision was made, when that decision was made and who it affected. See 5. New Business: Parcel Tax District Boundaries.

5. New Business:

Parcel Tax District Boundaries:

- On October 23, 2023 CLSD is notified of complaints from parcel owners in the "affected territory". DA Crowl explained in detail the cause of the complaints from approx.126 parcels previously deemed 'exempt',
- ➤ 1994 Resolution 43. Fort Ross School District boundaries were annexed by Coast Life Support District as the southern taxing boundaries.
- ➤ 2004 Resolution 136 allows CLSD to exempt properties from the CLSD parcel taxes that are "not serviced by CLSD ambulance response".
- ➤ 2012 NBS (third party administrator of CLSD parcel tax) audited CLSD database, added parcels identified being within the CLSD boundary but missing from the database. The added parcels were designated "exempt" with no notes or documents to support the exemption.
- 2020 Measure J ballots for both Mendocino and Sonoma Counties were sent out to the entire district on record. Sonoma County utilized the parcel tax map on record including the entire Ft. Ross School District. The excluded parcels noted above were never reported to Sonoma County Tax Collector.
- → 2023 NBS does annual audit of parcel taxes. There was no indication any exempted parcels.
- ➤ The FC discussed all details of the history and contributing facts. DA Crowl contacts Sonoma County and will be providing the supporting documents to include the updated parcel list. DA Crowl added that since CLSD does not offer a service to those parcels, they are exempt at this time.

- ➤ DA Crowl will be going to Sonoma County to update and adjust our service district map. This will ensure that any future ballot measures go to the correct property owners.
- ➤ In December 2023, CLSD expects to receive the first parcel tax payment from both Mendocino and Sonoma counties.
- ➤ The Parcel Tax and Districts boundaries issue will be added to the next BOD meeting agenda. During that BOD meeting, DA Crowl will inform the BOD of the inadvertent levy of taxes, and the measures were identified and taken to resolve this situation. It is recommended that NBS send a letter with an explanation to rectify the situation of those exempt from this tax. Director Schwartz moved to add this topic to the next agendaof the full BOD, seconded by Director Beaty. All ayes.

6. Old Business:

- **Ambulance Finance Options:** Captain Golly gave an in-depth report on purchasing options for a new Ambulance, as well as an option to fund the purchase.
 - ➤ Captain Golly met onsite at CLSD with a salesperson with whom we already have an established relationship. He brought a FR Ambulance demo unit for the crew to see firsthand. The demo unit was being offered up for sale at a discounted price to CLSD. There is another party interested in purchasing the unit. In the event the ambulance is sold, there is another coming directly off the assembly line to which the discount will be extended. Another option is a new Crestline Type 3 box style ambulance with a Ford E Series chassis and gas engine that will be available at the end of March. This is the most ideal option with a price tag up to \$200k. Captain Golly is awaiting more details pertaining to cost.
 - Financing Option: Community Leasing Partners: Equipment: one new Ambulance, estimated delivery February 2024, total cost: \$110,000.00 \$20,000.00 = \$90,000 financed (with tax and additional options closer est.~\$120k total) Payment frequency annual, interest rate: 6.49%, Payback options 4, 5 or 6 year options given. See November FC Agenda Packet pg. 5 for details.
 - ➤ The FC agreed that a decision could not be made until more information is received.
- **7. Finance: YTD: Ambulance Revenue**: Net payments for Oct 2023 totaled \$52,591.87 with A/R of \$342,943.84.
- 8. Expenses: Reviewed and within range.
- 9. Cash Flow: Reviewed.
- **10. Banking:** Reviewed. Charles Schwab: moved \$200k to Exchange Bank to cover expenses during the yearly low period.
- **11. Ambulance Transport data** October billable incidents 62 with 46 transports.
- 12. Other: GEMT Update:
 - The PP-GEMT IGT payment for CY 2023 Invoice #3 is due by 10:00 a.m. on Friday, December 15, 2023. \$26,919.12.
- **13. Shout out:** Treasurer Michael Tilles gave a shout out to DA Crowl for a great presentation to a group called Sonomen. Shout out to Scott Foster for all his help and sharing historical information regarding parcels that had been exempt from CLSD parcel tax bills.


