This includes the District Administrator (EMS Chief) and Clerk of the Board (Executive Administrator), who are considered District Officers. These positions also should have an employment contract.
- **District Counsel:** CLSD does not have the funds to keep legal counsel on retainer. Can we talk with the full Board about establishing a relationship with a legal firm that will work with us on an hourly basis when needed?

Chief Golly will discuss with President Beaty adding these items to the next Regular Board Meeting's agenda.
